RULES AND REGULATIONS OF COLLEGE HOSTEL

- 1) Admission to hostel will be confirmed only after the student has paid the hostel and mess charges.
- 2) Residing in the Institute's hostel, opting mess facility is compulsory, once admitted / opted will have to continue for one year. The charges will not be refunded if the student leaves the hostel / mess earlier or is expelled from the hostel / mess for whatsoever reason.
- 3) Drinking, Smoking and such other habits are strictly PROHIBTED in hostel, College and other places in City.
- 4) Students are required to share room. Hostel rooms allotted at the time of admission shall not be changed / exchanged during the academic year.
- 5) The rooms will be handed over to the occupant in a good condition. Any breakage / damage of hostel furniture thereafter will be borne by the occupant. Occupant is not allowed to do any repairs, unnecessary nailing and pasting pictures / posters on the wall.
- 6) Following furniture is provided in a room
- (a) One bed (per head) (b) Chairs (per head) (c) Writing / study tables (per head) (d) Ceiling fan
- (e) Tube light (f) Dustbin (g) Cupboard
- 7) Use of premises shall be subject to the rules and regulations and standing orders of VTC
- 8) Students are responsible for cleanliness of room and furniture. No rubbish will be thrown around the hostel premises
- 9) Student will be smartly dressed at all times. Torn uniforms, civies, linen are not permitted in mess, hostel & college.
- 10) Room inventory will be signed by the occupants and handed over to the warden / rector and clearance will be obtained before proceeding on leave. Dues if any will be paid out.
- 11) During semester end vacations, hostels will remain close for the renovation process and no student shall remain in the hostel.
- 12) Cooking is strictly prohibited in hostel rooms. No any flammable fuel is permitted in room.
- 13) Food, crockery, cutlery from the mess shall not be taken in the living/hostel room/dormitory.
- 14) Food will not be served in the room except in case of sickness. Warden/Rector/Coordinator of VTC must be informed of illness / untoward incident.
- 15) Students will strictly follow the mess timings menu and no request except in case of illness will be entertained for special personal menu. Working days: Lunch Timings: 01: 15 PM- 02:00 PM Dinner Timings: 07:30 PM- 08:30 PM Sundays & Holidays: Lunch Timings: 09: 30 AM- 11:30 PM Dinner Timings: 07:00 PM-08:30 PM
- 16) Visitors will be entertained only with prior permission obtained in writing from VTC office. 2 Photographs with address of guardian / visitors of students to be submitted by the parents to the warden / rector /VTC office (Strictly for Ladies Hostel). Visitors will enter their names in the visitor's book and will be permitted to meet the student only after the warden / rector endorses it. However they will not stay for what so ever reason in the hostel during night and students request for the same will not be entertained.
- 17) Visiting days will be all Holidays, weekends & off hours of working daysVisiting hours: Sunday09:30 AM -06:30 PM
- 18) Parents / Relatives are not permitted to visit the student during working hours of VTC/when classes are in progress.
- 19) Students remaining in the hostel during Institute timings for whatsoever reason without permission are liable to be expelled from the hostel and in such cases the student is not entitled for any kind of refund. Rejoining the hostel will be treated as fresh admission.
- 20) Discipline and Punctuality will be maintained at all times. Institute and hostel rules will be strictly adhered. Lapses in the rules may lead to disciplinary action against defaulters.
- 21) Lights / fans must be switched off when not in use. Water taps should be closed after use. Economical use of electricity and water is mandatory.
- 22) Students are not allowed to use electrical appliances viz. heaters, stoves etc in the rooms.
- Students are advised for their safety, not to play/fiddle with any electrical switches / plugs / fitments etc.
- 24) Any repair/damage/malfunctioning of any electrical appliances is to be reported to the warden/rector. The cost for the same shall be borne by the occupant(s).
- 25) Use of hostel telephone for outgoing calls is not permitted.

- 26)Unnecessary / unwanted / group discussions / gossips / meetings / abusing / quarreling in the rooms/hostel premises/outside are prohibited round the clock.
- 27) Warden / rector shall visit the rooms whenever need arises. Strict action shall be taken against students found violating any rules.
- 28) It is mandatory for every student to study during the study hours as mentioned without producing any excuse.

Morning: 06:00 to 08:15 AM Evening: - 06:30 to 10:00 PM (during working days considering dinner).

29)Every inmate shall report office of the hostel after out pass at **07.00 PM** without fail.Student escaping from the hostel after reporting time through illegal ways and means without intimation, for whatsoever reason is liable for disciplinary action.

The timings shall be followed strictly. Disciplinary action shall be taken against defaulters.

- 30) Students are admitted to the hostel taking into consideration they are medically fit, in case any communicable / fatal disease is brought into notice then the student(s) has to leave the hostel and will be allowed to rejoin only when a doctor's certificate that he/she is medically fit, is produced.
- 31) If any student falls sick, he / she will report to the warden. In case of hospitalization, a student will be detailed to stay in the hospital for a day after which parents / guardians will stay with student or make necessary arrangements.
- 32) In case of emergency parents can meet Rector / Registrar / Director of VTC through proper channel.
- 33) Students are responsible to the security of their money and valuables. They are advised not to keep jewelry/expensive items and excessive cash in their room/on person. Complain regarding damage/loss of such valuables will not be entertained.
- 34) Mobile phones, of any type are strictly prohibited, in case need arises student is to bring an application from parents regarding no objection in using mobile phone by the student. In such cases only simple mobile phones will be used by the student (no MMS/GPRS/Video/Camera etc mobiles). If a student is found with such mobiles or using the same for clipping photos/videos for illegal purposes/in illegal ways, his/her phone will be detained/apprehended and will be handed over to his/her parents & if found for the second time the phone will be confiscated and shall not be returned back. There will be close watch on wasting study time in sending SMS and surfing on internet.
- 35) Students seeking leave are to fill in their application forms atleast two days in advance. Urgent/immediate applications for leave will not be entertained except in case of sickness/untoward incident and such similar cases. Students will leave the Institute/ hostel only if the leave is sanctioned and after reporting to the warden/rector. It's mandatory for the student's to show the sanctioned leave applications to the warden/rector.
- 36) In case need arises to extend the sanctioned leave, student(s)/parent(s)/guardian(s) are to phone and inform the same to the concerned authorities/fax an appropriate handwritten application duly signed at VTC office.
- 37) No student holds the right to abuse / quarrel with other student(s) / people associated with the hostel and mess.

 Any kind of complaint regarding hostel / mess, its cleanliness etc is to be made in the VTC office in writing.
- 38) Students shall abide by the rules and regulations formed / altered from time to time.
- 39) Parents/guardians are advised to motivate and guide their ward(s) to abide by and follow all the rules and regulations of the Institute/hostel/mess or any part functioning/allied to the same.
- 40) All the rules and regulations are made / prepared for the convenience, betterment and safety of the students. Violating any of the rule(s) will lead to disciplinary action as per respective rules. Institute/hostel/any of the part functioning/allied to the same will not be responsible/entertain in case of theft of any sort/FIR launched against any student(s) or any mishap caused/happened with the student(s) due to violation of any of the rule(s) of the Institute/hostel/mess or any part functioning/allied to the same.
- 41)The caution deposit will be refunded only after the student leaves the hostel and obtains clearance from the VTC office. Any damage caused to the hostel property, the cost of the repairs will be deducted from the caution deposit.
